

The guidelines in this special publication are applicable to all federal information systems other than those systems designated as national security systems as defined in 44 U.S.C., Section 3542. The guidelines have been broadly developed from a technical perspective to complement similar guidelines for national security systems and may be used for such systems with the approval of appropriate federal officials exercising policy authority over such systems.13 State, local, and tribal governments, as well as private sector organizations are encouraged to consider using these guidelines, as appropriate.
